  - Racial literacy capacity expectation
    - The General Education Curriculum Committee has begun meeting although without a chair or co-chairs; the curriculum support team is engaged.
    - The majority of students will complete general education courses in the first 2
      years of study and graduation should not be delayed because there are not
      enough seats available for students to fulfill a requirement.
    - Darcy Mays created a projection model that can be used to determine seat capacity.

- Mignonne Guy has agreed to chair an Implementation committee with an initial focus being on racial literacy courses.
- The Implementation committee will work with faculty proposing racial literacy courses and assist them with building successful proposals.
- UUCC members posed the following questions and shared additional insights for consideration:
  - Can the number of seats needed come from departments or schools?
  - Are there numbers from other foundational courses that can be used?
  - Transfer credits can not be used to satisfy the racial literacy requirement.
  - Are DFW rates built into the projection model? If not, should they be?
  - Course proposals should include capacity.

#### • UUCC efficiencies

- CIM forms working group
  - The curriculum support team is considering if Google course application forms (i.e., general education and REAL) can be eliminated by building additional questions into the currently existing CIM form.

- Sandy Morgan is currently cross-checking the general education course application against the CIM form to determine if the difference is significant.
- Stephanie Thulin will organize this ad hoc working group and Rachel Hill and Elena Olson volunteered to serve.
- Others may be consulted as needed.

# REAL course application working group

- The CIM forms working group will also be tasked with reviewing the REAL course application in an effort to create efficiencies and incorporate questions into the currently existing CIM form.
- SCHEV actions committee
  - Rob DiRenzo and Lisa Yamin will engage this committee during a program idea phase in an effort to open up discussion around student demand and employability of graduates, among other areas.
  - Initiating these discussions prior to proposal work starting is meant to encourage conversations and collaboration within and across units.
  - Mariam Alkazemi and Yonella Demars volunteered to serve on this committee, in a limited capacity.
  - A Google form may be created to provide a brief description of the work of this committee and collect additional volunteers.
- Administrative actions committee
  - Faye Prichard will organize this committee to review <u>all</u> proposals submitted to the UUCC via CIM.
  - Committee members will use an approved list to determine which actions may be administratively approved.
  - Administratively approved actions will be listed as consent agenda items on UUCC agendas.
  - Mariah Crilley, Edna Renee Macbeth and Elena Olson volunteered to serve on this committee.
- Faye Prichard noted that those who serve on the SCHEV actions and Administrative actions committees will not be tasked with assignments during UUCC meetings.
